

## **The Everest Giveaway Trade Promotion (“the Promotion”) Standard Terms & Conditions:**

### **Eligibility**

- Entry is open to Australian Citizens and Permanent Residents of Australia only (as defined in the Australian Citizenship Act 2007 (Cth)) that have attained the age of 18 or over and are able to provide proof that they are permanently and legally domiciled in Australia at the time of their competition entry and the competition draw (“Eligible Entrants”)
- Employees, immediate family members of employees and employees of any company associated with the Promotion are ineligible to enter or receive a prize

### **Entry**

- The Promotion commences on 25/9/2017 and entries close on 16/1/2018 (“the promotion period”)
- Everest branded cookies will be gifted at random to members of the public during the promotion period with the packaging for each containing a unique code
- To enter, Eligible Entrants must enter the unique code attached to the packaging during the Promotion Period and via the website [www.theeverest.com.au/competition](http://www.theeverest.com.au/competition).
- There is to be a maximum of one entry per person. If multiple entries are discovered to have been made on behalf of the same person, Racing NSW reserves the right to declare the relevant entrant ineligible at any stage during or after the promotion period and the prize draws, including prior and/or subsequent prize draws as referred to under “Prize Conditions”

### **Prizes and winning**

- The main prize draw will take place on 14/10/2017 at Randwick Racecourse (“the main prize draw”)
- The main prize draw and all other prize draws that form part of the promotion will be randomized and the associated process will be scrutinised by an independent person as required
- The winner of the main prize draw will receive \$100,000 in prize money (“the main prize”) to be paid either by crossed cheque or otherwise the winner can elect to have the prize money paid by EFT into the winner’s nominated account
- In addition, there will be periodic supplementary prize draws conducted in the lead up to the main prize draw being (Prize A) , (Prize B) and (Prize C)
- The winner of the prize draw for Prize A will receive (entertainment package prize) (“Prize Draw A”)
- The winner of the prize draw for Prize B will receive (entertainment package prize) (“Prize Draw B”)
- The winner of the prize draw for Prize C will receive (entertainment package prize) (“Prize Draw C”)
- The total prize pool value is \$110,000 including both the main prize and all other prizes

### **Prize conditions**

- The winner will have 5 minutes to claim the main prize in person at the location of the prize draw (Randwick Racecourse) from the time their name is announced, after which time Racing NSW will attempt to contact the winner using any and all details provided by the entrant at the registration stage. If the winner is contacted and is not on-site at Randwick Racecourse (for any reason or combination of circumstances) to claim the main prize within 5 minutes of the initial announcement, they will be entitled to \$1,000 which becomes the main prize.
- With respect to any and all prize winners, the prize winners will be given 3 months from the date of the prize draw to claim their prize. In the event that any of the prizes remain unclaimed after 3 months from the date of the prize draw, Racing NSW will contact the Department of Liquor and Gaming in NSW for direction.
- As the prize value for Prize Draw A, Prize Draw B and Prize Draw C (“the minor prize draws”) is more than \$500, the winners of the minor prize draws will be notified by phone/email within two (2) business days of the draw.
